*Alex Bulat: A New Hope for Huntingdon* campaign understands that your privacy is important to you and that you care about how your personal data is used. We respect and value the privacy of everyone who visits our website and will only collect and use personal data in ways that are described here, and in a way that is consistent with our obligations and your rights under the law.

Please read this Privacy Policy carefully and ensure that you understand it. Your acceptance of this Privacy Policy is requested when you use our site and services.

### 1. DATA CONTROLLER

Our site is owned and operated by *Alex Bulat: A New Hope for Huntingdon* campaign; a selection campaign promoted by Alex Bulat as a candidate.

### 2. POLICY APPLICATION

This Privacy Policy applies only to your use of our site. Our site may contain links to other websites. Please note that we have no control over how your data is collected, stored, or used by other websites and we advise you to check the privacy policies of any such websites before providing any data to them.

### 3. WHAT IS PERSONAL DATA?

Personal data is defined by the General Data Protection Regulation (EU Regulation 2016/679) (the "GDPR") and the Data Protection Act 2018 (collectively, "the Data Protection Legislation") as 'any information relating to an identifiable person who can be directly or indirectly identified in particular by reference to an identifier'.

Personal data is, in simpler terms, any information about you that enables you to be identified. Personal data covers obvious information such as your name and contact details, but it also covers less obvious information such as identification numbers, electronic location data, and other online identifiers.

### 4. WHAT ARE MY RIGHTS?

Under the Data Protection Legislation, you have the following rights, which we will always work to uphold:

- The right to be informed about our collection and use of your personal data. This Privacy Policy should tell you everything you need to know, but you can always contact us to find out more or to ask any questions using the details in section 12.



- The right to access the personal data we hold about you. Section 11 will tell you how to do this.
- The right to have your personal data rectified if any of your personal data held by us is inaccurate or incomplete. Please contact us using the details in section 12 to find out more.
- The right to be forgotten, i.e., the right to ask us to delete or otherwise dispose of any of your personal data that we hold. Please contact us using the details in section 12 to find out more.
- The right to restrict (i.e., prevent) the processing of your personal data.
- The right to object to us using your personal data for a particular purpose or purposes.
- The right to withdraw consent. This means that, if we are relying on your consent as the legal basis for using your personal data, you are free to withdraw that consent at any time.
- The right to data portability. This means that, if you have provided personal data to us directly, we are using it with your consent or for the performance of a contract, and that data is processed using automated means, you can ask us for a copy of that personal data to re-use with another service or business in many cases.
- Rights relating to automated decision-making and profiling. We do not use your personal data in this way.

It is important that your personal data is kept accurate and up to date. If any of the personal data we hold about you changes, please keep us informed as long as we have that data.

Further information about your rights can also be obtained from the Information Commissioner's Office or your local Citizens Advice Bureau.

If you have any cause for complaint about our use of your personal data, you have the right to lodge a complaint with the Information Commissioner's Office. We would welcome the opportunity to resolve your concerns ourselves, however, so please contact us first, using the details in section 12.

## **5. WHAT DATA DO YOU COLLECT AND HOW?**

Depending upon your use of our site, we may collect and hold some or all of the personal and non-personal data below, using the methods also set out in the table. We do not collect any personal data relating to children NOR data relating to criminal convictions and/or offences.

Usage and analytics data, including information about how you interact with our website	By placing cookies on your machine with your explicit consent when you access this website.
Profile data, including your username, your interests and preferences in the support of the campaign, feedback and survey responses.	Through a form on the website, completed and submitted by yourself.
Marketing and Communications Data, including your preference in receiving content and/or marketing from us and your communication preferences.	Through a form on the website, completed and submitted by yourself.

## 6. HOW DO YOU USE MY PERSONAL DATA?

Under the Data Protection Legislation, we must always have a lawful basis for using personal data. The following table describes how we may use your personal data, and our lawful bases for doing so:

What We Do	What Data We Use	Lawful Basis
Contact you to discuss volunteering opportunities within the campaign team.	First name, surname, email address, postal address, telephone numbers.	We have explicit consent, as the data cannot be collected without you freely providing it.
Action payments by you to the campaign.	First name, surname, email address, payment card details, telephone number.	We have explicit consent, as the data cannot be collected without you freely providing it.
Track web activity on our site to tailor the user experience and provide analytics data concerning interest in the campaign.	Technical and cookie data, IP address, areas of site visited.	We have prior consent, freely given, when allowing cookies on our website.



With your permission and/or where permitted by law, we may also use your personal data for marketing purposes, which may include contacting you by email, telephone, text message or post with information and news on our work.

You will not be sent any unlawful marketing or spam.

We will always work to fully protect your rights and comply with our obligations under the Data Protection Legislation and the Privacy and Electronic Communications (EC Directive) Regulations 2003, and you will always have the opportunity to opt-out.

We will always obtain your express opt-in consent before sharing your personal data with third parties for marketing purposes and you will be able to opt-out at any time.

We will only use your personal data for the purpose(s) for which it was originally collected unless we reasonably believe that another purpose is compatible with that or those original purpose(s) and need to use your personal data for that purpose. If we do use your personal data in this way, and you wish us to explain how the new purpose is compatible with the original, please contact us using the details in section 12.

If we need to use your personal data for a purpose that is unrelated to, or incompatible with, the purpose(s) for which it was originally collected, we will inform you and explain the legal basis which allows us to do so.

In some circumstances, where permitted or required by law, we may process your personal data without your knowledge or consent. This will only be done within the bounds of the Data Protection Legislation and your legal rights.

## **7. HOW LONG WILL YOU KEEP MY PERSONAL DATA?**

We will not keep your personal data for any longer than is necessary in light of the reason(s) for which it was first collected. Your personal data will therefore be kept only for the duration of the parliamentary selection campaign.

## **8. HOW AND WHERE DO YOU STORE OR TRANSFER MY PERSONAL DATA?**

We will only store your data within the UK. This means that it will be fully protected under the Data Protection Legislation.

Please contact us using the details below in section 12 for further information about the particular data protection mechanism.

The security of your personal data is essential to us and to protect your data we take a number of



important measures, including the following:

- Limiting access to your personal data to those employees, agents, contractors, and other third parties with a legitimate need to know and ensuring that they are subject to duties of confidentiality.
- Procedures for dealing with data breaches (the accidental or unlawful destruction, loss, alteration, unauthorized disclosure of, or access to, your personal data) including notifying you and/or the Information Commissioner's Office where we are legally required to do so.

## **9. DO YOU SHARE MY PERSONAL DATA?**

We will not share any of your personal data with any third parties for any purposes, subject to the following exceptions.

- If we transfer or merge parts of our organisation or assets, your personal data may be transferred to a third party. Any new owner of our organisation may continue to use your personal data in the same way(s) that we have used it, as specified in this Privacy Policy.
- In limited and exceptional circumstances, we may be legally required to share certain personal data, which might include yours, if we are involved in legal proceedings or complying with legal obligations, a court order, or the instructions of a government authority.

## **10. CAN I WITHHOLD INFORMATION?**

Our site uses only marketing cookies from third parties and web traffic analytics so we can understand how our visitors use our site. If you wish to opt out some parts of our site will be inaccessible.

## **11. HOW CAN I ACCESS MY PERSONAL DATA?**

If you want to know what personal data we have about you, you can ask us for details of that personal data and for a copy of it (where any such personal data is held). This is known as a "subject access request".

All subject access requests should be made in writing and sent to the email shown in section 12.

There is not normally any charge for a subject access request. If your request is 'manifestly unfounded or excessive' (for example, if you make repetitive requests) a fee may be charged to cover our administrative costs in responding.

We will respond to your subject access request within 28 days and normally we aim to provide a complete response, including a copy of your personal data, within that time. In some cases,



however, particularly if your request is more complex, more time may be required up to a maximum of three months from the date we receive your request. You will be kept fully informed of our progress.

For your security we may require proof of identity, in this case we will contact you to request such proof, the 28-day time for our response to your request will then start from the point that we receive such proof.
